The under signed persons, in order to form a nonprofit corporation under Chapter 24.03 of the Revised Code of Washington, hereby adopt the following Articles of Incorporation.

ARTICLE I: Name

The name of this corporation shall be: Tacoma Linux Users Group. Hereafter referred to as TACLUG.

ARTICLE II: Duration

The duration of this corporation shall be perpetual.

ARTICLE III: Purpose

This nonprofit organization has purpose to provide information about, instruction in the use of, development in the science of, promotion of cooperative activities with individuals and business identities for, and collection of funds to help demonstrated the benefits of using the Linux operating system. This organization may expand in the future to to help organize specific and subsidiary user groups within the State of Washington.

ARTICLE IV: Conduct and Limitation of Business Activities

Section 1. TACLUG agrees to conform with all current and future State of Washington, Federal, and Local laws and regulations that pertain to conduct of non-profit business activities.

Section 2. The Taclug board and general memberships accept and agree to abide by the internal bylaws as written concurrently with these articles of incorporation and as legally modified in any form afterwards.

Section 3. Voluntary procedures may be adopted by this organization to order or limit business activity such as recognized rules of order, and the building and codification of organizational business procedures.

Section 4. Any business activities not limited from any of the sources previously stated in this Article, and in conformity to the purpose of this organization, may be pursued to a logical fulfillment by TACLUG and its members.

ARTICLE V: Dissolution


Net assets of TACLUG, after payment to outstanding debtors, will be dispersed to any other non-profit organization as determined by the board membership.
